



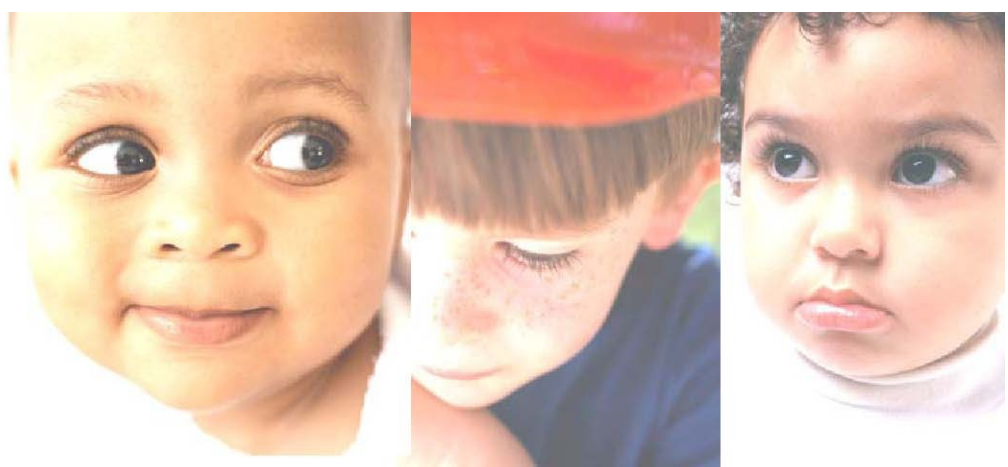

- CHS will process your form with the state and then you will receive a tax certificate to be used with your tax forms.

## Tax Credits

All you need  
to do...

1. Make a contribution to Children's Home Society. Note "PACTS" on the memo portion of your check.
2. Complete & return the tax credit form provided by CHS.
3. File your tax return and Form MO-TC to receive an additional 50% credit on your Missouri State Tax Liability.

Eligible contributions can be made in the form of a cash donation, stocks, bonds, or mutual funds by both individuals and businesses.

## Receive a 50% Missouri State Tax Credit through YOP Tax Credits
